I, Matthew W.H. Wessler, declare as follows:

1. I am over the age of 18 and reside in the District of Columbia.
2. I am competent to testify to the matters set forth herein based on my own personal knowledge.
3. I am a member in good standing of the bar of the District of Columbia, Bar No. 985241.
4. California Code of Civil Procedure Section 1281.96 requires private arbitration companies, such as the American Arbitration Association ("AAA") and JAMS, Inc. ("JAMS"), to collect and publish certain categories of information "regarding each consumer arbitration . . . commenced on or after January 1, 2003." Pursuant to Section 1281.96, AAA and JAMS publish a quarterly report containing the statutorily required information.

5. Section 1281.96 does not require, and neither AAA nor JAMS identify in their reports, the state of residence for the non-consumer parties involved in the arbitrations. Section 1281.96 does not require, and neither AAA nor JAMS identify in their reports, any attorneys' fees awarded in the arbitration.

6. I have reviewed the most current quarterly report published by AAA, which, according to AAA's report legend, "is based upon consumer cases filed after January 1, 2003." The complete AAA report is available through download at <http://www.adr.org/sp.asp?id=22042>. AAA also provides a report legend at <http://www.adr.org/sp.asp?id=22042> (both accessed June 13, 2011), which I have also reviewed. The AAA report purports to contain information from April 1, 2006 to March 31, 2011.

7. According to AAA's report legend, employment disputes are included in the quarterly report. Employment disputes are denoted by an entry in the column labeled "Salary Range."


8. The most recent quarterly report lists 43 consumer arbitrations involving American Express or American Express affiliates (identified by searching "American Express" in the report and including "American Express," "American Express Bank, FSB," "American Express Centurion Bank," "American Express Company," "American Express Financial Advisors, Inc." "American Express General Counsel's Office," "American Express Membership Rewards," "American Express Travel Related Services Co., Inc.," and "American Express, Inc.").

9. Of these 43 consumer arbitrations, 14 were classified as "Consumer Disputes – Other" while the rest were classified either as employment disputes, "Consumer Debt Collection," or "Banking." Exhibit A to this declaration is a true and correct excerpt of AAA's report showing the arbitrations involving American Express or an American Express affiliate.

10. I have also reviewed the most current quarterly report published by JAMS, which, according to JAMS's "Disclosure for Consumer Arbitrations," "provides information regarding consumer arbitrations administered in California." This "Disclosure for Consumer Arbitrations" is available at <http://www.jamsadr.com/consumer-arbitration-disclosures/> (last accessed June 13, 2011). The complete JAMS report is available at <http://www.jamsadr.com/files/Uploads/Documents/JAMS-consumer-arbitrations.pdf> (last accessed June 13, 2011).

11. The most recent JAMS quarterly report lists 9 consumer arbitrations involving American Express or American Express affiliates (identified by searching "American Express" in the report and including "American Express," "American Express Centurion Bank," "American Express Company," and "American Express Publishing Company"). Each of the 9 arbitrations is classified as "Business/Commercial." Exhibit B to this declaration is a true and correct excerpt of JAMS's report showing the arbitrations involving American Express or an American Express affiliate.

I declare under the penalty of perjury under the laws of the District of Columbia that the foregoing is true and correct, and that this Declaration was executed on June 27, 2011, in Washington, D.C.
