TWO-YEAR LEGAL FELLOWSHIP STARTING FALL 2021 WASHINGTON, D.C. (preferred) or OAKLAND, CA

Public Justice is a public interest legal advocacy organization dedicated to pursuing high-impact lawsuits to combat social and economic injustice, protect the Earth's sustainability, and challenge predatory corporate conduct and government abuses. We seek to hire a two-year Fellow starting in Fall 2021 who will work with our attorneys on high-impact, cutting-edge litigation and advocacy across a variety of substantive areas. Our strong preference is for this position to be based in our Washington D.C. office.

The Fellowship

This is a two-year Fellowship in which the Fellow will have the opportunity to work on variety of substantive areas encompassed by our projects, including the Access to Justice Project, which works to dismantle the procedural and structural barriers that corporations try to place between ordinary people and the civil justice system; the Debtors' Prison Project, which combats the criminalization of poverty where indigent defendants are jailed and imprisoned for inability to pay fines and fees; the Student Civil Rights' Project, which uses litigation and advocacy to address the many forms of gender violence that occur in schools and ensure survivors' access to education; the Food Project, which addresses the structural and institutional inequities on which our current food system is built; and the Environmental Enforcement Project, which holds corporate polluters accountable through impactful lawsuits.

The Fellow would work closely with Public Justice's attorneys who have extensive experience litigating and advocating in their areas of expertise, a network of lawyers who collaborate on Public Justice's work, other public interest groups, and our communications staff. In addition, the Fellow would be responsible for responding to intake and providing assistance with organization-wide projects as requested. This is an exempt position and will report to a Senior Attorney.

Qualifications

- J.D. degree (by Fall 2021).
- Admission to a state bar or pending admission.
- Excellent analytical, legal research, legal writing, and speaking skills.
- Litigation experience (e.g., from internships, clinics, or clerkships).
- Ability to juggle multiple tasks at a time and work in a fast-paced environment.
- Self-motivation and proven ability to work independently and as part of a team.
- Sensitivity to the needs and concerns of, and ability to work well with, individuals and groups from diverse cultures, backgrounds, and orientations.

- Excellent attention to detail and commitment to follow-through.
- Strong organizational skills.
- Healthy sense of outrage and desire to change the world for the better.
- Experience in complex civil litigation is preferred.
- Willingness to travel on occasion. Because Public Justice handles litigation, education, and advocacy nationally, the position may entail some travel once travel is safe again.

We offer a mission-focused work environment and a teamwork approach. We also offer a generous benefits package, including three weeks of paid vacation, two weeks of sick leave, and two personal days each year, all federal holidays, employer-paid health, dental and vision insurance premiums, and a 401(k) plan. The annual salary will be \$55,150.

Your application should consist of two electronic files: (1) your cover letter, resume, law school transcript, and references in a single .pdf file; and (2) a writing sample in another .pdf file, comprised of a legal brief or persuasive memo for which you were the primary author (please note the contributions of others). In your cover letter, please specify whether you are applying to work in the Washington, D.C. or Oakland, CA office. Candidates applying to work in D.C. are preferred.
