## Declaration of Phillip Urquidi


1. I am 25 years old. I was born in Sylmar, CA and raised in Canoga Park.
2. I was arrested approx 10pm Wed. NOV. 9 for vandalism in Sepulveda and taken to ~~Septon~~ <sup>Devonshire</sup>. The officer who arrested me told me I would be released the next morning (Thurs).
3. I was taken to Devonshire and then transferred to the LAPD Van Nuys jail where I have been ever since. I am being held on \$25,000 bail.
4. I was told ~~my~~ my bail amount when a woman in a blue uniform interviewed me.
5. I ~~do~~ do not have the money to pay bail or even to pay 10% to a bail bond company. No one has asked me whether I can pay.
6. I have NOT been assigned an attorney to represent me. I cannot afford to hire my own attorney.
7. I have NOT spoken with a judge or magistrate since I've been here.



13. It is a struggle to meet our basic needs.
14. Since I have been jailed, I have lost access to the 2 prescription medications I take. No one has even asked me if I am taking medication or if I am OK without them.
15. I was ~~told~~ informed by the Public Justice attorney that I could call the bail deviation number. When I called, they told me my case is a "D.A. reject" and that I should be released, because the DA is declining to charge me. But that was early this afternoon, and nothing has happened.
16. If I could afford to buy my freedom, I would. The conditions here are awful - expired food, trash everywhere, it's unsanitary.

I declare under penalty of perjury under the laws of the state of GA that the foregoing is true and correct to the best of my knowledge.
